ABANDONED VEHICLES POLICY

1. SCOPE

This Policy applies to all Tenants, ex-Tenants and Household Members of Evolve Housing Limited and its controlled entities, excluding Evolve Housing Vic Limited (referred to as the Company), including their visitors.

2. POLICY STATEMENT

The Company is committed to maintaining a satisfactory standard of property conditions.

This Policy outlines the role of the Company in addressing abandoned Vehicles on Evolve Housing properties.

Vehicles that are stored, abandoned or parked inappropriately on Evolve Housing property can present a health or safety hazard, cause a nuisance, block access or prevent other Tenants and Residents from utilising the space. Tenants and Evolve Housing are responsible for taking reasonable precautions to prevent Vehicles from being left, stored or abandoned on Evolve Housing property. Evolve Housing can take action to remove such Vehicles if they are on Evolve Housing property.

Vehicles left on public land are the responsibility of local councils or the NSW Roads & Maritime Services. A reference to a Vehicle includes a car, motorbike, caravan, trailer, boat or remains of any vehicle belonging to a Tenant or a Household Member.

2.1 When a Tenant may be in breach of their Residential Tenancy Agreement

A Tenant may be in breach of their Residential Tenancy Agreement if their Vehicle, whether registered or unregistered, is on Evolve Housing property and is:

- Parked in a space reserved for emergency vehicles;
- Parked for more than seven days in a space reserved for visitors;
- Occupying a car space intended for other Tenants;
- In a common area and is blocking access or causing a hazard;
- In an open carport, back or front yard and is in a state of disrepair, has been stripped or is a hazard;
- Appears to have been abandoned.

3. DEFINITIONS

 Household members – all people, regardless of age or relationship to the Tenant, living in the home with the Tenant

- Resident a person who resides on a permanent basis in a property which is owned or managed by Evolve Housing under a Residential Tenancy Agreement (includes a Tenant)
- <u>Residential Tenancy Agreement</u> (or Tenancy Agreement) a written agreement between Evolve Housing (as Landlord) and a Tenant, which governs the terms on which that Tenant occupies the property described in the Agreement.
- <u>Tenant</u> a person who signs the Residential Tenancy Agreement with Evolve Housing and who has certain rights and obligations under that Agreement
- <u>Vehicle</u> a car, motorbike, caravan, trailer, boat or anything else specified as a vehicle by the NSW Roads & Maritime Services, which belongs to a Tenant or one of their Household Members. This includes the remains of any such vehicle.
